SUPPLEMENTARY TRUST DEED

16/09/2009 31971/H

This Deed of Supplementary Trust Deed is executed on this 17th July, 2009, by Dr. Mohammad Athar, son of Late Mr. Mohammad Ahmed, resident of 123 B, LIG Flats Pocket 12, Jasola Vihar, New Delhi – 110044, hereinafter called the Settler & Trustee and Salman Khurshid, son of Khurshid Alam Khan, residing at 4, Gulmohar Avenue, Jamia Nagar, New Delhi – 110025; and Mukhtar-ul-Amin, son of Chaudhuri Ehsan Karim, <sup>and Sakina</sup> <sub>Mukhtar</sub> wife of <sub>son</sub> <sup>Mukhtar</sup> <sub>ul</sub> <sub>Amin</sub>, both residing at 15/202-E, Civil Line, Kanpur, hereinafter called the Trustees (which expression shall, unless it be repugnant to subject or context, mean and include the survivor or survivors of the settler trustee and the trustees for the time being of these presents) hereby declare and state as follows:

WHERERAS a Trust Deed in the name of 'Modern Education Foundation' having its registered office at 4, Gulmohar Avenue, Jamia Nagar, New Delhi-110025, was registered vide Document No. 4480, in Addl. Book No. 4, Volume No. 2983, pages from 107 to 115 on 26.11.2001, in the office of Sub-Registrar, New Delhi (Copy Enclosed ).

AND WHEREAS Board of Trustees in its meeting held on 27.5.2009, decided to amend the said Trust Deed by adding under mentioned para below para 34 of the said Trust Deed

35. That :-


- a) The Director of Education will be entitled to nominate a member on the Board of Management of the every school running under trust.
- b) At least 10% seats will be reserved for the meritorious children of scheduled caste/scheduled tribes and school will not charged fee more than fee prescribed for the schools run and managed by the Uttar Pradesh Madhyamik Shiksha Parishad/Basic Shiksha Parishad. The students of the different categories will be granted the fee concessions as prescribed under rules 105 to 107 of Uttar Pradesh Educational Manual, if applicable.
- c) The school will not demand any grant from the State Government.
- d) The pay scales and allowances of the vocational and non vocational staff will not be less than the employees of Government Aided Education Institutions.
- e) The service rules of the employees will be prepared and the employees will get the retirement benefits equal to employees of Government Aided Higher Secondary Schools.
- f) The School will follow the orders of the State Government issued from time to time.
- g) The record of the School will be kept in the prescribed format.
- h) No any alteration/amendment/addition will be made in the aforesaid conditions without prior approval of the State Government.

That this Supplementary Trust Deed should be read along with the Principal Trust Deed dated 26.11.2001.


